

**ORDINANCE NO. 2009-01**

**AMENDMENT TO ORIGINAL SEWER RATE ORDINANCE**

**AN ORDINANCE AMENDING THE ORIGINALLY ESTABLISHED SCHEDULE OF RATES AND CHARGES TO BE COLLECTED BY THE FALLING WATERS CONSERVANCY DISTRICT FROM THE OWNERS OF PROPERTY SERVED BY THE SEWAGE WORKS OF SAID DISTRICT AND OTHER MATTERS CONNECTED THEREWITH.**

WHEREAS, the Falling Waters Conservancy District is the owner and operator of a sanitary sewer collection and treatment facility and originally adopted a schedule of sanitary sewer rates and charges on August 31, 2005; and,

WHEREAS, it has now been deemed necessary to amend the aforementioned schedule of rates and charges so as to produce sufficient revenue to pay expenses for maintenance, operation and to provide funds for necessary replacements and improvements of the sanitary sewer collection and treatment facilities, all in a manner in accordance with the guidelines of the Indiana Department of Environmental Management and so as to provide funds for other necessary and appropriate expenditures related to the ownership and operation of the Falling Waters Conservancy District sanitary sewer collection and treatment facilities.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE FALLING WATERS CONSERVANCY DISTRICT AS FOLLOWS:**

Section 1. That Section 3(a) of Ordinance 2005-01 should be and the same is hereby amended to read as follows:

(a) All Class I and II Users

The sewage rates and charges shall be determined by equivalent single-family dwelling units (ESFDU), except as herein provided. Sewage service bills shall be rendered for periods of service equaling one month. The schedule on which said rates and charges shall be determined is as follows:

Operation, Maintenance and Replacement Charge  
Rate per ESFDC per month



Section 2. That all other sections and provisions of Ordinance 2005-01 shall remain in full force and effect and shall be controlling as to all matters related to the districts schedule of rates and charges for collection of sanitary sewage and treatment within the Falling Waters Conservancy District.


SECTION 3. That this Ordinance amending Ordinance 2005-01 shall be in full force and effect and the new rates and charges contained herein shall be effective as of the conservancy district sanitary sewer service billing which will be due and owing in ~~August~~, 2009 and from and after its passage, approval, recording and publication as provided by law. <sup>Sept.</sup>
